# Where should the chemical indicators be placed in instrument sets for sterilization?

Chemical indicators (CI) should be placed in an area within the package that presents a challenge for air removal and sterilant contact. When there is a question concerning the appropriate number and placement of internal CIs, the CI manufacturer, the device manufacturer, and the containment device manufacturer should be consulted for additional information.

The number and placement of internal CIs may be affected by the contents of the package, the configuration of the items within the set, and the packaging or containment device.

# Which patient skin antiseptic products are flammable? How can I minimize the fire risk when using these products?

Alcohol-based skin antiseptic agents may be flammable or combustible. The product material safety sheet should be reviewed to determine if a specific product is a potential fire fuel source. Because the potential for a fire exists in the presence of the triad of oxygen, ignition sources (eg, electrosurgical units, lasers, light cords); and fuel (i.e., alcohol based skin antiseptic), it is critical that perioperative personnel receive education on the flammability of certain antiseptic products.

In addition, the following interventions relating to the use of prep antiseptic products can minimize the fire risk in the OR:

- Allow sufficient drying time, including time for the vapors to dissipate, before applying surgical drapes, using an active electrode or laser, or activating a fiber-optic light cable.
- Use the smallest amount possible for a single application.
- Do not allow the product to pool on or under body parts.
- Remove wet materials.
- Include the fire risk assessment in the "time-out" period.

#### What is the temperature range for solution warming cabinets? How long can fluids remain in the warmer?

#### **Answer:**

The temperature range of solution warming cabinets should be in accordance with the solution manufacturer's specifications. Contact the solution manufacturer for maximum temperature and length of time that the fluids may remain in the warming cabinet. The stability of the fluids will vary by the type of solution and the storage container.

Post the temperature and length parameters on the cabinet for ready reference. Label and date the fluids with either the date into the warmer or the date the fluids should be removed. Be consistent within your facility. The temperature of the warming cabinet should be checked on regular intervals and documented on a log or electronically.

#### **Educational Presentation:**

"Accurate Estimation of Blood Loss in the Perioperative Setting"

Kristy Simmons, MSN, RN, CNOR, Woman's Hospital (Baton Rouge, LA)

How accurate is our calculation of blood loss? Are our calculations accurate? When do we give blood?

These were a few of the questions that Kristy asked that led to the initiation of his research project.

A pre-test was given to find the current knowledge and level of accuracy with estimated blood loss . . . and the estimates were all over the place and with little accuracy!

The most accurate method to determine blood loss is to weigh the sponges. This is impractical in many cases. Kristy wanted to find an easier way to estimate blood loss but to also be more accurate.

Kristy set up four stations with moist and dry sponges/products to test our knowledge! Here are the results of how much a moist and dry sponge/product can absorb:

- Moist Lap = 70ml
- Dry Lap = 100ml
- Moist Sponge = 7ml
- Dry Sponge = 10ml
- Partially Saturated Peri-Pad = 50ml
- Saturated Peri-Pad = 100 ml
- Half-Saturated Blue Pad = 200ml
- Fully Saturated Blue Pad = 400ml

# Kristy's findings:

Experience in the OR didn't have an effect on accuracy of blood loss estimation.

Blood loss estimation accuracy improved greatly after education of staff.

To maintain the improved accuracy, other interventions included:

- Developing clinical guidelines and policies/procedures on accurately estimating blood loss would help in determining when to replace lost blood volume.
- Creating a visual reference (posters/scales) to measure blood loss.
