Federal - HR 6 Opioid Bill

#### Federal - HR 959

A bill to amend title VIII of the Public Health Service Act to extend advanced education nursing grants to support clinical nurse specialist programs, and for other purposes. Support

## Federal - HR 4174

A bill to amend titles 5 and 44, United States Code, to require Federal evaluation activities, improve Federal data management, and for other purposes.

Advocacy is the act or process of pleading for, supporting, or recommending a cause or course of action. Advocacy may be for persons (whether as an individual, group, population, or society) or for an issue, such as potable water or global health. (ANA Code of Ethics -2015)

Every day, in countless large and small ways, you make the world a better place. These moments of everyday advocacy change lives by elevating the voices of vulnerable people, and improving conditions for those around you.

As the largest group of health professionals in America, and consistently the highest ranked in terms of ethical behavior by the public, nurses are in a unique position to influence the direction of both the profession and healthcare.

Louisiana became the 31<sup>st</sup> state in the nation to enact the Enhanced Nurse Licensure Compact (eNLC) on May 31, 2018 when Governor John Bel Edwards signed Senate Bill 202 into law. After discussions with the Louisiana State Board of Practical Nurse Examiners with whom we are collaborating, the implementation date for both agencies has been set for July 1, 2019. We will keep all licensees apprised of our progress through email, The Examiner, and website announcements. Until implementation, RNs licensed in Louisiana hold single state licenses, not Compact multistate licenses and are not authorized to

Continuing Education Presentation: Back to Basics: Guideline Review and Commenting presented by Christal Cook.

## \*\* CHAPTER ELECTIONS \*\*

An Official Ballot will be sent in the May Newsletter with voting instructions and the winners will be announced at the May Chapter meeting. The newly elected officers will be installed in June at our Installation ceremony.

A "Willingness to Serve" form can be found in this Newsletter. Please consider serving your chapter and being active in your professional organization.

The officers of this Association are President, President-Elect, Vice President, Secretary, and Treasurer and Board of Directors with responsibilities outlined in the Chapter Policy Manual.

The President-elect is elected every year and serves in that capacity for one year and then automatically becomes President for a term of one (1) year.

The Treasurer and two (2) members of the Board of Directors are elected in the odd numbered years for a term of two (2) years.

The Nominating Committee is an elected committee of the Chapter and shall be elected in the manner provided in the bylaws. The committee shall consist of two (2) active members elected for a term of one (1) year. The chairman of this committee is automatically the immediate past president.

## PRESIDENT-ELECT

## Responsibilities

- 1. Observes and assists the President in preparation for the duties and responsibilities of that office.
- 2. Represents the President and the Chapter at other professional meetings as delegated by the President.
- 3. Acts as a member of the Board of Directors with full power and responsibility of that office.
- 4. Serves as a member ex-officio on standing and special committees and may chair committees as delegated.
- 5. Serves as the Chairman of the Delegates at the Annual AORN Surgical Conference and Expo.

#### **TREASURER**

## Responsibilities

- 1. Signs all checks as approved by the Board of Directors.
- 2. Presents financial statement at each board meeting and business meeting.
- 3. Collects all money from fund raising projects and deposits immediately.
- 4. Chairs Ways and Means Committee.
- 5. Verifies automatic deposit against membership renewal on monthly statement.
- 6. Maintains tax-exempt status through annual filing of the IRS 990 form.
- 7. Provides a yearly financial report to the AORN Chapter Relations Coordinator to include Income and Expenses.
- 8. Participates in the annual fiscal audit with two members appointed by the President.

## NOMINATING COMMITTEE

## Responsibilities

This committee shall:

- 1. Present a ballot to the membership for Officers, Board members, State Council alternate, and Nominating Committee at the monthly meeting (April) prior to the election meeting.
- 2. Select qualified candidates for each office, considering the individual's active participation in, attendance at meetings, and contribution to the organization. The committee shall take into consideration the various hospitals and the private surgical nurses, so that equal representation may be assured. The committee shall take into consideration transferred members who have been active in other Chapters.

#### BOARD OF DIRECTORS

## **Definition**

The Board of Directors is composed of the officers and members elected by the membership. The Board of Directors is charged with the overall responsibility of conducting the affairs of the Chapter.

## **Philosophy**

The philosophy of the Board of Directors is to act in the best interest of the membership by conforming to the purposes for which the Association was formed as outlined in the bylaws.

## Responsibilities

The Board of Directors shall:

1. Direct the business and financial affairs of the Chapter.

## **Individual Responsibilities**

- 1. Serve on committees as assigned.
- 2. Be expected to attend all Board of Directors' meetings. If a member finds that it is impossible to fulfill this obligation, the member shall be expected to submit a resignation. If a member becomes non-functioning and does not resign voluntarily, an unexcused absence from two consecutive meetings means automatic resignation.
- 3. Keep oneself well informed on the activities of the Chapter and AORN, Inc.
- 4. Conduct oneself in accordance with the position held, so as to reflect prestige upon the Chapter.
- 5. Arrive promptly for meetings and come prepared to discuss items of business. Board members must attend a majority of monthly meetings.
- 6. Accepts and completes special assignments as made by the President.
- 7. Advise the President when on vacation or of other travel activities, as the President should know where and how to contact each member of the Board of Directors at all times in case an emergency.
