# Legislative Report by Nathalie Walker, MBA, RN, CNOR

Legislative information from ANA website:

For decades, the American Nurses Association has been advocating for health care reforms that would guarantee access to high-quality health care for all. With the passage of the Patient Protection and Affordable Care Act (PPACA), millions of people have greater protection against losing or being denied health insurance coverage, and better access to primary and preventive services. ANA recognizes the debate of health care is ongoing, and the organization remains committed to educating the nursing public about how the changing system impacts our lives and our profession.

ANA continues to deliver nursing's message, provide resources, develop solutions and take action to ensure the successful implementation of health reform while continuing to represent the interests of the nation's nurses and patients.

In December 2016, we delivered a <u>letter</u> to then President-elect Trump outlining ANA's Principles for Health System Transformation.

## **ANA's Principles for Health System Transformation 2016**

The system must: Ensure universal access to a standard package of essential health care services for all citizens and residents.

This includes:

- An essential benefits package that provides access to comprehensive services, including mental health services.
- Prohibition of the denial of coverage because of a pre-existing condition.
- Inclusion of children on parent's health insurance coverage until age 26.
- Expansion of Medicaid as a safety net for the most vulnerable, including the chronically ill, elderly and poor.

Optimize primary, community-based and preventive services while supporting the cost-effective use of innovative, technology-driven, acute, hospital-based services. This includes:

- Primary health care that is focused on developing an engaged partnership with the patient.
- Primary health care that includes preventive, curative, and rehabilitative services delivered in a coordinated manner by members of the health care team.
- Removing barriers and restrictions that prevent RNs and Advanced Practice Registered Nurses (APRNs) from contributing fully to patient care in all communities.
- Care coordination services that reduce costs and improve outcomes with consistent payment for all qualified health professionals delivering such services, including nurses

Encourage mechanisms to stimulate economical use of health care services while supporting those who do not have the means to share in costs. This includes:

- A partnership between the government and private sector to bear health care costs.
- Payment systems that reward quality and the appropriate, effective use of resources.
- Beneficiaries paying for a portion of their care to provide an incentive for the efficient use of services while ensuring that deductibles and co-payments are not a barrier to receiving care.
- Elimination of lifetime caps or annual limits on coverage.
- Federal subsidies based on an income-based sliding scale to assist individuals to purchase insurance coverage.

Ensure a sufficient supply of a skilled workforce dedicated to providing high quality health care services. This includes:

- An adequate supply of well-educated, well-distributed, and well-utilized registered nurses.
- Increased funding, whether grant or loan repayment based, for programs and services focused on increasing the primary care workforce.
- Funding to elevate support for increasing nursing faculty and workforce diversity.

# "Skinny repeal" fails in early-morning vote

The health care debate, mixed with a hearty dose of politics, has been nothing short of a wild ride. However, in an unexpected turn of events, **the attempt to repeal the Affordable Care Act failed** in a Senate vote of 49 – 51, early this morning. Three GOP senators, Susan Collins, Lisa Murkowski and John McCain, voted against the "skinny repeal" plan, as did all 48 Democrats. Thank you to the nurses who spoke out; your advocacy and commitment makes all the difference to patients in need of access to health care. ANA will remain vigilant in our fight to protect our patients' right to better health care.



### FROM THE EXECUTIVE DIRECTOR



2-YEAR BIENNIAL LICEN-SURE RENEWAL IS COM-ING IN 2017 FOR YOUR 2018 RN/APRN LICENSE.

I am very pleased to report that Louisiana is moving to biennial licensure that will allow RNs and APRNs to renew their licenses for two (2) years. This transition becomes effective with the license renewal period begin-

ning October 1, 2017 for your 2018 active license. The LSBN Board approved the plan at the April 20, 2017 board meeting. We will join the 45 other states who currently have biennial licensure. Only Connecticut, Kentucky, Washington and West Virginia will remain as single year license states. Iowa has 3 year licensure and Arizona has 4 year licensure. The original plan was to have license renewal on birthdays, but in response to concerns voiced by our nursing organization partners throughout the state, we have decided to maintain our current policy of renewing licenses beginning October 1st of each year and continuing through December 31st. January is provided as a 'grace period' for late renewals and renewal during this month will continue to include a late renewal fee along with the regular license fees. The driving forces behind the change are to eliminate the onerous task of RNs and APRNs having to renew their license annually and to assist LSBN in providing improved and timely service to our constituents. Not only will this plan provide you better customer service during renewal season, it will allow LSBN to allocate greater resources to improving professional practice in the state and collaborating with our community partners on nursing workforce development. We will be using a graduated system to move all licensees to the new biennial system. Licensees whose last name begins with the letters A-M will renew during the 2018 renewal season and will be renewing their licenses for a 2-year period. Such biennial licenses will be active from January 1, 2018 and expire on December 31, 2019. Licensees whose last name begins with the letters N-Z will renew during the 2018 renewal season and will be renewing each of their licenses for a 1-year period with renewed licenses active from January 1, 2018 and expiring December 31, 2018. Licensees whose last name begins with the letters N-Z will begin biennial renewal processes next year during the 2019 renewal season that begins in October 2018. Using this method, by renewal year 2019, we will be renewing half of our licensees each year

for a 2-year cycle. LSBN will be developing a **Frequently Asked Questions (FAQ)** sheet in the near future to address all the questions and concerns that will come with our new process. This will be distributed to all RNs and APRNs in Louisiana through your email on file with the agency and through communications in **The Examiner** and on our website. We promise to keep you posted and to work with all our constituents as we implement this new process.

2017 LEGISLATIVE SESSION. Following is a summary of the legislative action that occurred in the 2017 session that had implications for LSBN:

- SB75 authored by Senator Mills provided relative to the health profession licensing boards created within the Louisiana Department of Health (LDH) and would have provided increased oversight of the health profession licensing boards by the Department of Health. The bill would have increased the responsibility of LDH to provide greater oversight of the licensing, education preparation and regulatory activities of each of the licensing boards including greater fiscal oversight. The bill also would have required that each health licensing board have at least one (1) consumer member, an action that LSBN had already taken in 2016 with the change to our Nurse Practice Act requiring two (2) consumer members of the board. The most concerning change to licensing board regulation would have been in the area of board hearings, which would have been transferred to the sole jurisdiction of an administrative law judge. It was readily acknowledged by the health licensing boards that administrative law judges were experts in criminal and civil law and legal proceedings under the administrative procedures act. There was concern, however, that these judges would have less expertise than disciplinespecific board members in the complexities of each of the health disciplines. The bill was defeated in House Health & Welfare Committee.
- HB490 authored by Representative Walt Leger and sponsored by Senator Mills creates the Advisory Council on Heroin and Opioid Prevention and Education within the Drug Policy Board; to provide for the membership, powers, and duties of the council; to require an Interagency Heroin and Opioid Coordination Plan; to provide for
