Meeting Minutes - from the secretary:

PLEASE REVIEW September Chapter MEETING MINUTES ON PAGES 4 & 6 for approval.

The September chapter meeting took place on September 24th at Delgado. Melissa Guidry, President, called the meeting to order at 4:44 pm. Melissa thanked Ann Burghart-Dieck for arranging this meeting. Ann introduced the speaker Goldie Baker-Huguenel, RN. She is one of the nurses in the documentary "An American Nurse" project by Carolyn Jones. Carolyn was asked to interview nurses for this project. Her director Lisa Franks helped her put this project together. They traveled the country to interview nurses. The DON at University suggested she be interviewed for this project. Goldie was at Charity Hospital before, during and after Katrina. Goldie was interviewed by Carolyn. Only 75 nurses were chosen to represent nurses. Goldie was one of the 75.

Goldie has been a patient liaison at University since 1994. She is certified in bereavement counseling. She helps families deal with a medical crisis. She locates next of kin to notify them of crisis. She helps families deal with the death of loved ones. Bereavement counseling, sympathy cards, listens to family members, works with pastoral care and nursing staff. She is non-judgmental in her care of families. Some have been mothers of murderers. She has learned to cherish life, because it can be taken away so quickly. The best thing to say to a bereaved family is "I am so sorry for your loss." Don't say "I know how you feel." Listening without judgment is the best thing to do.

Melissa thanked Goldie for such an inspiring presentation and thanked Ann for working hard to get the CE credits for this meeting. She asked everyone if they had any corrections for the September meeting minutes that were in the September newsletter. There were no corrections and a motion was made by Frances Hughes and were seconded Mary Anne Toledano.

<u>Treasury Report:</u> Sharon Giardina reported that the chapter has \$4212.47 in treasury.

The bylaws changes were posted in the August newsletter for review. Melissa asked if anyone had any changes or additions. Nathalie Walker made a motion to approve the changes. Sharon Giardina seconded the motion.

TRIVIA CORNER FROM THE



For a TB patient, where should the disposable bacterial filter be placed?

A single-use, disposable bacterial filter should be placed between the anesthesia circuit and the patient's airway.

Placing a bacterial filter between the anesthesia circuit and the patient's airway prevents contamination of the anesthesia equipment and release of tubercle bacilli into the room.

Does wearing gloves replace hand hygiene?

Wearing gloves does not replace hand hygiene. One study found a 15% rate of colonization from methicillin-resistant Staphylococcus aureus (MRSA)-positive patients to health care personnel's hands after removal of gloves. Another study found a 17% rate of colonization from MRSA-colonized patients to gloves of health care personnel.

How often should OR humidity levels be checked?

Relative humidity should be maintained within the HVAC design parameters. The facility needs to determine the frequency of monitoring in consultation with accrediting agencies.

How often should reusable cleaning materials be changed?

How often should reusable cleaning materials be changed?

Reusable cleaning materials should be changed after each use. Disposable cleaning materials should be discarded after each use.

Using a dirty mop or cloth on a clean area or to clean for multiple patients may increase the possibility of cross-contamination.

General Instructions

Section references are to the Internal Revenue Code unless otherwise noted.

Purpose of Form

A person who is required to file an information return with the IRS must obtain your correct taxpayer identification number (TIN) to report, for example, income paid to you, real estate transactions, mortgage interest you paid, acquisition or abandonment of secured property, cancellation of debt, or contributions you made to an IRA.

Use Form W-9 only if you are a U.S. person (including a resident alien), to provide your correct TIN to the person requesting it (the requester) and, when applicable, to:

- Certify that the TIN you are giving is correct (or you are waiting for a number to be issued),
 - 2. Certify that you are not subject to backup withholding, or
- 3. Claim exemption from backup withholding if you are a U.S. exempt payee. If applicable, you are also certifying that as a U.S. person, your allocable share of any partnership income from a U.S. trade or business is not subject to the withholding tax on foreign partnership share of foreign partners' share of effectively connected income.

Note. If a requester gives you a form other than Form W-9 to request your TIN, you must use the requester's form if it is substantially similar to this Form W-9.

Definition of a U.S. person. For federal tax purposes, you are considered a U.S. person if you are:

- An individual who is a U.S. citizen or U.S. resident alien,
- A partnership, corporation, company, or association created or organized in the United States or under the laws of the United States.
- An estate (other than a foreign estate), or
- A domestic trust (as defined in Regulations section

Special rules for partnerships. Partnerships that conduct a Special rules for partnerships. Partnerships that conduct a trade or business in the United States are generally required to pay a withholding tax on any foreign partners' share of income from such business. Further, in certain cases where a Form W-9 has not been received, a partnership is required to presume that a partner is a foreign person, and pay the withholding tax. Delegate Information/Willingness-to-Serve Form

Delegates shall represent the local Chapter at the annual National Conference meetings. The Chapter is entitled to elect at least one delegate and one alternate, based on total active membership. The alternate delegate has the same responsibilities as the delegate. An alternate delegate is one who shall be seated in the delegate section only in the absence of the delegate. Once an alternate has been moved up to delegate status, the status is maintained for the duration of the Conference. Total delegate numbers are determined by our National Association.

Election of Delegates - Eligibility

- 1. A delegate and alternate delegate must be a current member of AORN. Delegates are chosen on a point system.
- 2. A delegate and alternate delegate should have attended at least six (6) general meetings the previous year, based on ten (10) meetings a year.
- 3. A delegate and alternate delegate must have active participation on a local AORN committee the previous year.
- 4. The President and President-elect are automatically delegates and the President-elect shall act as Chairman of Delegates. Other eligible members must fill out a "Willingness to Serve" form on or by the designated meeting.
- 5. The number of eligible persons receiving the highest number of points will be selected as delegates and the next number of highest points will be the alternate delegate.
- 6. Eligibility requirements may be waived in lieu of insufficient candidates.

Provisions for Delegates

- 1. Delegates are required to fulfill all duties at the Conference. Failure to do so will result in the delegate returning a prorated amount of their funding to the Chapter. This amount is determined based on the number of mandatory delegate activities.
- 2. If an alternate is selected, they will be funded their Conference registration.
- 3. If the alternate needs to be seated as a delegate at the Conference, the alternate will be funded the prorated amount of the unseated delegates' funding.

Credentials

- 1. Chosen delegates/alternate must indicate their status as either delegate or alternate on their Conference registration form.
- 2. Delegates shall register at delegates' booth with the following:
- a. Current RN registration/licensure.
- b. Current AORN membership card.
- c. Official delegate authorization letter from National Headquarters.
- 3. Delegates are required to wear official badge at all business meetings of the Association.

Responsibilities

- 1. Delegates and alternate delegate shall become familiar with and adhere to directions forwarded from National Headquarters, prior to attending the National Conference.
- 2. Attend all business sessions and special delegate activities at the Annual National Congress.
- 3. Delegates shall seek information on all issues under discussion, and act in the best interest of the Chapter.
- 4. Delegates are encouraged to vote as recommended by the Chapter on all issues and for National Officers.
- 5. Shall relate to members from other areas and evaluate them in light of their leadership potential so that the Chapter may submit names of prospective candidates for an elected national office.
- 6. Attend educational and scientific meetings and exhibits at the National Congress.
- 7. The Delegates Chairman shall give a meaningful report to the Chapter following attendance at the National Congress, and submit a written report for publication in the Chapter newsletter.
- 8. Delegates designated to any Annual Congress shall continue in their office as delegates for the purpose of any special meeting of the National Association that may be called until the delegates are duly designated for the next Annual Congress and likewise for the local Chapter that they may be called until the delegates are duly designated for the next Congress.
- 9. Delegates must attend pre-Congress Meetings, called by the Chairman.

GUIDELINES FOR DELEGATE SELECTION

- 1. Chapter membership for a pre-determined time before Congress.
- 2. Attendance at a given number of monthly meetings for the year preceding.
- 3. Active participation in Chapter affairs, service on a committee, program participant, etc., for a year previous to selection.
- 4. The President and President-Elect are automatically delegates.
- 5. Assignments as a delegate may be an incentive award for a member other than an officer, if that person has contributed greatly to the functioning of the Chapter.
- 6. The amount of money that is available from the treasury will determine how the Chapter funds its delegates. Funds are distributed by the Treasurer prior to Congress.
- 7. Delegates are required to fulfill all duties at Congress. Failure to do so will result in the delegate returning a prorated portion of their funding to the Chapter. This amount is determined based on the number of mandatory delegate activities.
- 8. Any delegate/(s) failing to fulfill obligation in regard to voting and attendance at meetings may not serve as delegate for one year.
- 9. Headquarters recommends points system as the only fair way to choose delegates.
