## **Louisiana Legislative News**

The 2018 regular session of the Louisiana Legislature will convene Monday, March 12, 2018. Final adjournment no later than 6:00 p.m. on June 4, 2018. However, LSNA never takes a break from advocating on behalf of professional nurses.

Throughout the year, LSNA networks with stakeholders, partners, and elected leaders to ensure our voice is heard at the policy table. LSNA engages the services of the Southern Strategy Group in Baton Rouge. LSNA will host the 2018 Membership Assembly, Link to the Legislature, on April 24-25, 2018 at the Capitol Hilton in Baton Rouge. The event will include NURSE DAY AT THE CAPITOL on Wednesday, April 25, 2018. Details, registration, and complete schedule will be released no later than December 1, 2017.

**Continuing Education Program:** Accreditation Readiness for Perioperative Service Teams

**Speaker**: Aimee Keating, MSN-HCSM, RN, Tulane Health System (aimee.keating@hcahealthcare.com)

The Joint Commission changed to using the Safer Matrix in the accreditation process. In the past, a pattern was needed for it to be cited. This is no longer true. This has resulted in about 30% increase in RFIs. Keep in mind that the goal is to make it safer for patients. Approach it from a consultative view.

Preparation can help calm anxiety related to the survey. Goal is to have the staff comfortable answering questions.

Tips for interacting with a surveyor:

- Be available and polite.
- Answer ONLY the question that was asked. DO NOT volunteer information.
- Ask for clarification if you don't understand the question.
- Go to a private place for the surveyor to review the chart (helps prevent breach of confidentiality!)
- Use your resources if you don't know the answers!

To start getting a unit ready, go for the low hanging fruit:

- Start with storage areas (separation of clean from dirty [and how do you know!], not <18" from the ceiling)
- Maintain appropriate egress
- Evaluate appropriate PPE in restricted areas; removed when leave the area
- Temperature, humidity, and air exchanges are correct
- Monitoring of temp, code cart, quality control logs
- Check for expired supplies and medications

- Remove clutter and trash
- Check for visible patient information
- Assure that fire equipment/alarms and medical gas valves are not blocked

Strategies to tackle the low hanging fruit:

- Educate staff to help them to buy into the process
- Make quick sweeps and use a general tracer [use checklists]
- Be observant and hold staff accountable
- Consider instituting a "Department of MINE" My Ideas Needed Everyday – staff taking ownership of a specific area. If it is everyone's responsibility, no one takes responsibility! Acknowledge and reward staff for accountability and results!.
- Do spring cleaning

Address Bigger Issues in Each Phase of Care

## Preop

- Completion of all required documents
- Appropriate preop education of the patient to give informed consent
- Site marking by surgeon (doing the procedure)
  with patient involvement. Know your policy for
  sites that are not able to be marked. Staff needs
  to know how to speak to issues related to site
  marking
- H & P within 30 days; Needs to be updated if not done on day of surgery
- Standard handoff to the intraoperative team; is there a process for the staff to be able to ask questions (especially if a form is used)
- Auditing areas for compliance. Set clear expectations and stick with it!

#### Intraoperative

- Proper identification of the patient at every phase of care
- o Active involvement of everyone in time-out
- Immediate pre-induction anesthesia assessment (need to see a note that anesthesiologist [or surgeon for procedural area] documents no changes noted or other note – even in procedural areas)
- Proper debriefing
- Label all medications outside of original

## **Meeting Minutes – Continued**

- o packaging on and off of the sterile field
- Document and communicate proper implementation of fire safety.
- Postop
  - Immediate post-op note needed when patient gets to PACU
  - Medication reconciliation across the continuum of care
  - Ensure post-anesthesia assessment occurs within 48 hours. Patient needs to be out of anesthesia (becomes conscious) before this occurs!
- Sterile Processing
  - Proper high level disinfection and sterilization of reusable medical devices (scopes, instruments, etc). Know and be able to articulate the process.
  - Staff competencies, education and training documented. A one-time inservice does not demonstrate competency. Do safe checks and audits of the actual process.

- Post the processes in the area so that all can see.
- Plan for continual readiness
  - Start with a general tracer to highlight areas of concern (a general OR tracer with key areas use to hone in on issues identified). Identify an action plan.
  - Utilize audits and focused tracers to gain more information
  - Educate and remove barriers to compliance. The problem may be with a process that can be modified to facilitate compliance.
  - Use a model for just culture to address issues identified.
