CHAPTER ELECTIONS

Nominations are being accepted at this time for the **2023-2024 Chapter term.** The ballot will close 30 days after the April Newsletter is printed. An Official Ballot will be sent in the May Newsletter with Voting instructions and the winners will be announced at the May Chapter meeting. The newly elected officers will be installed in June at our Installation ceremony.

A "Willingness to Serve" form can be found in the Newsletter. Please consider serving your chapter and being active in your professional organization.

The officers of this Association are President, President-Elect, Vice President, Secretary, and Treasurer and Board of Directors with responsibilities outlined in the Chapter Policy Manual.

The President-elect is elected every year and serves in that capacity for one year and then automatically becomes President for a term of one (1) year.

The Treasurer and two (2) members of the Board of Directors are elected in the odd numbered years for a term of two (2) years.

The Vice-President, Secretary and three (3) members of the Board of Directors shall be elected in the even numbered years for a term of two (2) years.

The Nominating Committee is an elected committee of the Chapter and shall be elected in the manner provided in the bylaws. The Nominating committee shall consist of two (2) active members elected for a term of one (1) year each year. The chairman of this committee is automatically the immediate past president.

PRESIDENT Responsibilities

- 1. Presides at all meetings of the Chapter and of the Board of Directors.
- 2. Shall be a member ex-officio, of all committees except the Committee on Nominations.
- 3. Represents the Chapter at meetings of other organizations or designates an alternate.
- 4. Approves chairman of all standing and special committees.
- 5. Offers guidance to all committees in their activities.
- 6. Directs the preparation of, and signs when applicable all official communications.
- 7. Speaks on behalf of the Board on all official matters.
- 8. Keeps Board and membership totally informed of all Chapter activities as received from AORN, Inc.
- 9. Responds promptly to all communications from AORN, Inc. and insists that all officers communicate promptly as necessary with AORN, Inc.
- 10. President and the President-elect (if applicable) must be in close contact at all times, so that it becomes almost a team. This assures continuity when the President-elect becomes President.
- 11. Call Board Meetings with as much notice as possible.
- 12. Updates online election results immediately after election.
- 13. At the end of the fiscal year, *an* audit of the Chapter's financial records is done done performed by two members, appointed by the President and to be completed by the August meeting.
- 14. Reviews the online Chapter membership Chapter roster for address changes and new, renewing and lapsed members. Communicates this information with the Membership Committee and Newsletter Committee.
- 15. Checks rosters carefully for errors. Errors are reported to AORN Chapter Relations Coordinator.
- 16. Shall prepare or designate the required applications for National or Chapter Awards.
- 17. Signs checks as needed in the absence of the Treasurer.

PRESIDENT-ELECT Responsibilities

- 1. Observes and assists the President in preparation for the duties and responsibilities of that office.
- 2. Represents the President and the Chapter at other professional meetings as delegated by the President.
- 3. Acts as a member of the Board of Directors with full power and responsibility of that office.
- 4. Serves as a member ex-officio on standing and special committees and may chair committees as delegated
- 5. Serves as the Chairman of the Delegates at the Annual AORN Surgical Conference and Expo.

VICE-PRESIDENT Responsibilities

- 1. Performs the duties of the President in case of the President's absence or inability to act.
- 2. Performs such other duties as may be delegated by the President.

- 3. May chair committees as delegated.
- 4. Serves as the designated representative to the Louisiana State Council of AORN Chapters for their term of office.

SECRETARY Responsibilities

- 1. Takes and maintains original minutes of all meetings of the Board of Directors and of the Chapter.
- 2. Writes correspondence for the Chapter at the direction of the President.
- 3. Submits the written Chapter meeting minutes to the newsletter editor for publication in the Chapter newsletter.
- 4. Assures a copy of the minutes are available at regular meetings for reading by the membership.
- 5. Makes changes or corrections of the Chapter minutes as directed by the approval of the membership.
- 6. Provides one copy of a business meeting minutes to AORN Chapter Relations Coordinator per year.
- 7. Provides AORN Chapter Relations with an updated copy of Chapter Bylaws no less than every other year.

TREASURER Responsibilities

- 1. Signs all checks as approved by the Board of Directors.
- 2. Presents financial statement at each board meeting and business meeting.
- 3. Collects all money from fund raising projects and deposits immediately.
- 3. Chairs Ways and Means Committee.
- 4. Verifies automatic deposit against membership renewal on monthly statement.
- 5. Maintains tax-exempt status through annual filing of the IRS 990 form.
- 6. Provides a yearly financial report to the AORN Chapter Relations Coordinator to include Income and Expenses.
- 7. Participates in the annual fiscal audit with two members appointed by the President.

BOARD OF DIRECTORS

Definition

The Board of Directors is composed of the officers and members elected by the membership. The Board of Directors is charged with the overall responsibility of conducting the affairs of the Chapter.

Philosophy

The philosophy of the Board of Directors is to act in the best interest of the membership by conforming to the purposes for which the Association was formed as outlined in the bylaws.

Responsibilities

The Board of Directors shall:

1. Direct the business and financial affairs of the Chapter.

Individual Responsibilities

- 1. Serve on committees as assigned.
- 2. Be expected to attend all Board of Directors' meetings. If a member finds that it is impossible to fulfill this obligation, the member shall be expected to submit a resignation. If a member becomes non-functioning and does not resign voluntarily, <u>an unexcused absence from two consecutive meetings means automatic resignation.</u>
- 3. Keep oneself well informed on the activities of the Chapter and AORN, Inc.
- 4. Conduct oneself in accordance with the position held, so as to reflect prestige upon the Chapter.
- 5. Arrive promptly for meetings and come prepared to discuss items of business. Board members must attend a majority of monthly meetings.
- 6. Accepts and completes special assignments as made by the President.
- 7. Advise the President when on vacation or of other travel activities, as the President should know where and how to contact each member of the Board of Directors at all times in case an emergency.

NOMINATING COMMITTEE Responsibilities

This committee shall:

- 1. Present a ballot to the membership for Officers, Board members, State Council alternate, and Nominating Committee at the monthly meeting (April) prior to the election meeting.
- 2. Select qualified candidates for each office, considering the individual's active participation in, attendance at meetings, and contribution to the organization. The committee shall take into consideration the various hospitals and the private surgical nurses, so that equal representation may be assured. The committee shall take into consideration transferred members who have been active in other Chapters.

Guest Speaker - Casey Banos, Stryker "Retained Surgical Items"

A "never" event - adverse event or sentinel event. This occurs in 1:10000 surgical procedures which equals to 11 times a day. Communication failures are at the root of most of these events. It is not a matter of if but when this will happen. Some contributing factors are problems with hierarchy/intimidation, no count being done, increased BMI, absence of P&P plus many others reasons. False correct counts occur in 80% of RSI cases. A RSI impact to the patient is 94.4% suffer temporary or permanent injury. Impact to the nurse is fear of repercussions and impact to the hospital is affect on reimbursement, lawsuits and publicity. Costs associated with RSI is \$600,000 for one with \$77,512 cost for 2nd procedure and follow up care. In 2022, AORN recommended the use of an adjunct technology device in the Guidelines.

Next Meeting - planned for Wednesday, March 22, 2023. We will be reviewing National ballot and voting. Location will be forthcoming. No additional business - meeting adjourned at 745pm.

*Senate Bill for a Smoke Free Plume was authored by Senator Gerald Boudreaux from District 024, Lafayette. The Bill has been reviewed by attorney's and will be presented this session. The basis of the proposed law is any facility using energy based devices; i.e., electrocautery, lasers, etc. must adopt and implement policies for the use of a surgical smoke plume evacuation system. All are encouraged to write to their legislative representatives and voice your support of this Bill.
